### AMENDMENT TO DECLARATION

(ADDING PHASE NO. 1, SECTION NO. 2)

THIS AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS, made and published this the \_\_\_\_\_\_\_ day of April, 2016, by ASIL GROUP, LLC, a Georgia limited liability company, hereinafter referred to individually and collectively as the "Declarant".

NOW, THEREFORE, for and in consideration of the premises and of the benefits to be derived by Declarant and its successors in title, and to each and every subsequent owner of any of the lots, tracts or parcels hereinafter described, Declarant does hereby modify and amend the said Declaration of Covenants, Conditions, Restrictions and Easements, dated July 28, 2015, and recorded in Deed Book 6917, Pages 149-173, Clerk's Office, Houston Superior Court, and amended by instrument of record in Deed Book 6949, Pages 71-72, said Clerk's Office, in the following particulars, to-wit:

Additional Property Subject to Declaration of Covenants, Conditions Restrictions and Easements. The following described lots, tracts or parcels of land shall be, and the same hereby are made, subject to the terms, provisions and conditions set forth in said Declaration of Covenants, Conditions, Restrictions and Easements, and said Declaration of Covenants, Conditions, Restrictions and Easements are hereby modified and amended so as to include the following described lots, tracts or parcels of land (the "Additional Property"), to-wit:
