The meeting was motioned to call to order by Judy; Dave seconded. Called to order at 6:00pm.

### **President's Comments.**

-Karen discussed the unsavory email published by Larry Cornwell. Judy offered an apology. The email resulted from a multitude of home improvement requests and covenant violations (approximately 15) being presented in one day to the ACC. All but two of those notifications were sent within the 10-day period of response. Regardless, the email published was unprofessional and uncalled for. **Treasurer's Report**. Michelle submitted. She informed the BoD that now there were 63 homeowners still in arrears for Annual Assessments. WHOA had two liens from 2023 cleared. Dave motioned to approve the reports and Judy seconded the motion. All Approved.
