SPEEDING: A constant problem throughout the neighborhood is speeding. We ask that you observe the posted 25 MPH signs and watch out for children, pets, and walkers. Golf carts are allowed. However, the operator must be above the age of 12 as long as they are accompanied by a licensed driver (18 years or older).

FLAGS: Flags cannot exceed 48 inches in length per the covenants.

SIGNS: Per Covenant Para. 6-10, "No sign of any kind shall be displayed to the public view on any lot except for the professional sign of a licensed real estate sales broker or agency advertising the property for sale or rent, or signs used by a builder to advertise the property during the building and sales period."

Homeowner's Dues

Many people often ask "Just what do my dues go toward?"

Below are examples of expenses in which your dues are used:

- Invoices are mailed in November with a due date of every December 1st.

$\diamond\diamond$ The following PROPOSED Changes to the Community By-Laws will appear on the 2025 Ballot for your vote: $\diamond\diamond$

Question 1: For the 2026 board election and going forward each year, we will increase the number of board members from five to seven positions: President, Vice President, Secretary, Treasurer, and three At-Large positions. In 2026, four board positions will be elected for a two-year term and three will be elected for a one-year term. Subsequent elections will ensure continuity by rotating term lengths between the positions and only requiring a portion of the board to be voted on each year.

Question 2: Starting with the 2026 election, the board has the option to run the election electronically via email and the website or by hard ballot and snail mail. The electronic option could save the association over \$3000 per year.

The Election process starts with nominations to the board of directors. Each home is allowed to nominate up to five candidates to be placed on the ballot in the upcoming November election.
