SECTION 3 - Bylaw Changes

Proposal One Check here if you support the proposal: _____

Unless otherwise amended, the number of directors shall be not less than five (5), and not more than seven (7) to be elected for two-years. The directors shall hold positions numbered 1,2,3,4,5,6,7 based on the total number of votes each director receives. Positions 1,2,3 shall sit for election on years when the election is held on an odd year, positions 4,5,6,7 shall sit for election on years when the election is held on an even year.

For the November 2025 election, all seven (7) positions will sit for election with positions 4,5,6,7 serving a one-year term and will sit for election for November 2026. Each election thereafter will follow the schedule set out in the first paragraph. The directors shall be elected in the manner set forth in Section 5.04 infra.

Proposal Two Check here if you support the proposal: _____

All elections of the Board of Directors shall be made by written ballots or by electronic ballots which shall (i) describe the vacancies to be filled; (ii) set forth the names of those nominated by the Nominating Committee or by nomination of the members for the vacancies; and (iii) contain a space for a write-in vote by the members for each vacancy. The ballot shall be prepared and mailed or emailed, if an email is on file with the Secretary of the WHOA and has been confirmed to be the email address of the member by the Secretary within one year of the date of the election, at least fourteen (14) days in advance of the date set forth therein for a return which shall be a date no later than the day before the Annual Meeting or any special meeting called for the purpose of electing Directors.
